Initiated in 2018, the MIL-GEM project envisaged the construction of four corvettes for the Pakistan Navy - two in Pakistan and two in Turkey. Turkish Vice President Cevdet Yilmaz was also present at the

CPEC, Shehbaz said turning the multi-billion dollar infrastructure project into a trilateral arrangement would bring regional prosperity and empower people through the best facilities, including education and health.

"I think all three nations can benefit from the potential of the CPEC which has been a big success," the prime minister underlined. While Pakistan and China describe their relations as "all-weather", Pakistan and Turkey, both Muslimmajority nations, enjoy close bilateral ties.

Islamabad (PTI): Pakistan's election commission on Wednesday deferred the indictment of Imran Khan again in a case linked to the contempt of the top electoral body and its head till August 22 after the former prime minister failed to appear before it in person.

The Election Commission of Pakistan (ECP) initiated contempt proceedings against Khan, 70, and former leaders of his Pakistan Tehreek-e-Insaf (PTI) party, Asad Umar and Fawad Chaudhry, last year for allegedly using 'intemperate" language against the chief election commissioner and the electoral watch-

Indian woman who went missing from cruise ship is dead, says son

Singapore (PTI): The 64-yearmissing after she fell overboard from a ship as it sailed through the Strait of Singapore from Penang, the northern island state of Peninsular Malaysia, has died, her son said on Wednesday. Reeta Sahani and her husband Jakesh Sahani, 70, were on their way back to Singapore from Penang aboard the Spectrum of the Seas on Monday, which was also the last day of the couple's four-day cruise, when she fell off from the vessel into the Singapore Strait.

The woman's son Vivek Sahani in an Instagram post wrote, "... we have unfortunately learnt that my mother has passed away. Would request you guys to give us some privacy as we mourn her loss."He also thanked the Ministry of External Affairs and its minister S Jaishankar, and the Indian High Commission here for "for helping us out in getting this closure". "Ironically, today is also her birthday," Vivek said. The High Commission here said it is in touch with the grieving family and is facilitating visas for the family members. Earlier in a series of tweets on Tuesday, the Mission said it was in "constant touch with the Sahani family since the news of the unfortunate incident reached us. The High Commission was also in close contact with Singaporean authorities to address related issues and is facilitating legal procedures.

The Mission said that it had also reached out to the India head of the Royal Caribbean cruise company to extend all cooperation."We remain fully committed to supporting the family in this testing time," the High Commission had said. The Singapore Strait is a 113-km long and 19-km wide busy shipping route between the Strait of Malacca and the South China Sea with Singapore on the north of the channel. The Maritime and Port Authority of Singapore has deployed two patrol craft to help in the search in Singapore's waters, while 22 vessels are also assisting in the search for the missing passenger, the Channel News Asia reported.

Death toll rises to 63 in Pakistan suicide blast

Peshawar (PTI): The death toll from the powerful blast triggered by an Islamic State suicide bomber at a convention of a hardline Islamist party in Pakistan's restive Khyber Pakhtunkhwa province has risen sharply to 63, authorities said on Wednesday. The attack took place on

Sunday when more than 400 members of the conservative Jamiat Ulema Islam-Fazl (JUI-F) party, known for its links to hardline political Islam, had gathered for a meeting under a large tent in the town of Khar, which borders Afghanistan.

The banned terrorist group Islamic State (ISIS) claimed responsibility for the suicide attack, which injured over 120 people in Khar, the capital of the Bajaur tribal district.

According to Dr Liaqat Ali of the District Headquarters Hospital, 43 bodies were brought to the hospital after the blast, and so far, a total of 63 people have died in the Bajaur blast, The Express Tribune newspaper reported. Ali added that one severely injured person died at the Lady Reading Hospital (LRH) Peshawar, while four died at Combined Military Hospital Peshawar and two at Timergara Hospital. He said that 13 bodies were handed over to relatives, the report said.

A total of 123 people were injured in the suicide blast and are undergoing treatment in different hospitals in the province, the hospital administration said.

An FIR was registered by the Khyber Pakhtunkhwa Counter-Terrorism Department against unknown suspects on charges of terrorism, murder, attempted murder and others in connection with the bombing. The local branch of ISIS has previously targeted JUI-F party leaders as they con-

Ranil Wickremesinghe to pursue 13th amendment for Tamil reconciliation

Sri Lankan President Ranil Wickremesinghe plans to press ahead with his quest for the full implementation of the 13th Amendment as part of his reconciliation efforts with the country's minority Tamil community, presidential officials said on Wednesday. The minority Tamil community in Sri Lanka has been demanding the implementation of the 13th Amendment that provides for devolution of power to it.

The 13th Amendment (13A) was brought in after the India-Sri Lanka agreement of 1987. It created 9 provinces as devolved units with a temporary merger of the Northern and Eastern provinces.

Presidential officials said Wickremesinghe would deliver a speech in parliament next week when it is reconvened for

its regular session. 'The President will outline his plan to implement it with all powers that could be granted to



provincial councils," an official said.During an all-party meet-ing last month, Wickremesinghe had said that all powers, except police powers, could be granted to the

councils. He would also submit to parliament all proposals received from different political parties on the full implementation of the 13A. However, the main Tamil party - the Tamil National Alliance (TNA)

More than 6.5 billion people, or 81% of the world's population, sweated through at least one day where climate change had a significant effect on the average daily temperature, according to a new report issued Wednesday by Climate Central, a science nonprofit that has figured a way to calculate how much climate change has affected daily weather. "We really are experienc-

ing climate change just about everywhere," said Climate Central Vice President for Science Andrew Pershing. Researchers looked at 4,711 cities and found climate change fingerprints in 4,019 of them



said is the hottest month on record. The new study calculated that the burning of coal, oil and natural gas had made it three times more likely to be hotter on at least one day in those cities. In the US, where the climate effect was largest in Florida, more than 244 million people felt greater heat due to

climate change during July. For 2 billion people, in a mostly tropical belt across the globe, climate change made it

hotter every single day of July. Those include the millionperson cities of Mecca, Saudi Arabia and San Pedro Sula, The day with the most

widespread climate-change effect was July 10, when 3.5 billion people experienced extreme heat that had global warming's fingerprints, according to the report. That's different than the hottest day globally, which was July 7, accordClimate Reanalyzer. The study is not peer-reviewed, the gold standard for
