HC extends Imran Khan's bail till June 8 Military vows to try 'spoilers'

Pakistan high court on A Pakistan night court on Tuesday extended bail of former prime minister Imran Khan in two cases pertaining to inciting violence and sedition until June 8. A single bench of the Islamabad High Court (IHC) heard the pleas in cases pertaining to allegations against top officers of state institutions and the manhandling of Pakistan Muslim League-Nawaz (PML-N) leader Mohsin Ranjha by

Khan's supporters.
Chief Justice Aamer Farooq after hearing the arguments by the lawyers extended Pakistan Tehreek-e-Insaf (PTI) chief's bail till June 8. The extension was given after the court also granted the former prime minister exemption from court appearance for the

Justice Farooq also inquired about the registration of a first information report related to Khan's arrest made from the court's premises. The attorney general responded that a Supreme Court verdict is pending in the case.

Last week, the IHC had granted 70-year-old Khan bail, barring the authorities from arresting him in all the cases registered beyond May 9 and asked him to approach the Lahore High Court for further relief on May 15.

Khan has been implicated in scores of cases since his ouster from power in April last year. He alleged that all the cases were politically motivated. Meanwhile, the Lahore

High Court (LHC) on Tuesday reserved the verdict on Khan's petition seeking bail in all cases registered against him in Punjab province following his arrest in the Al Qadir Trust case last week that sparked violent protests by his supporters.

În the Al Qadir Trust case, in which the National Accountability Bureau arrested the former cricketerturned-politician on May 9, the IHC granted him pre-arrest bail for two weeks.

The Supreme Court had declared Khan's arrest from the IHC premises illegal and referred the matter to the IHC. Meanwhile, Khan on Tuesday

The former premier stated that he "consistently" told his party workers "that whatever the provocation they must only do peaceful protests".

Khan was ousted from ower in April last year after losing a no-confidence vote in his leadership, which he alleged was part of a US-led conspiracy targeting him because of his independent foreign policy decisions on Russia, China and Afghanistan.

'Good to see you': CJ US supports freedom of expression sans violence

Amidst a domestic turmoil in Pakistan, the United States on Monday voiced support to freedom of expression without any violence and reiterated that a strong, stable and prosperous Pakistan is crucial to its ties with the "Our belief is that individ-

uals should have the freedom to express themselves, but do so without participating in any violence, violence that would put government employees in government buildings in harm's way. And specifically on the arrest, I spoke a little bit to this last week," state department's Deputy Spokesperson Vedant Patel told reporters at his daily news conference, referring to former prime minister Imran Khan's arrest last week by the Pakistani Rangers.

"The US does not have a position on one political party or one candidate or other.

Our view is a strong, stable and prosperous Pakistan is crucial to US-Pakistan relations and that for any arrest that such an individual is affronted basic human rights in accordance to their laws," he said, responding to a question on the ongoing developments

Asked about the freedom of press in Pakistan, Patel said he is not going to be prescriptive about the current situation.

"I do not have an assessment to offer from here. But broadly, we are very clear about the need for access for media and the access for information and the free flow of information between the government and journalists," he

Khan's arrest from the Islamabad High Court premises last Tuesday triggered unrest in Pakistan that continued till Friday and led to several deaths and dozens of military and state installations being destroyed by the protesters.

For the first time in Pakistan's history, the protesters stormed the army headquarters (GHQ) in Rawalpindi and also torched the corps commander's house in Lahore.

Police put the death toll in violent clashes to 10 while Khan's party claims 40 of its workers lost their lives in the firing by security personnel.

On Monday, Khan appeared before the Lahore High Court, which fixed his bail hearing on Tuesday in the terrorism cases registered against him following his arrest in the Al-Qadir Trust corruption case that sparked violent protests by his supporters.

The military commanders also resolved to support all such efforts to reach this much-needed consensus.

Meanwhile, in response to the Pakistan Army's statement, PTI tweeted that as a "responsible & the largest political institution in the federation of Pakistan, PTI has an unwavering commitment to the constitution & democracy."


